#### **Report Purpose**

## **Background**

## **Report Purpose**

The purpose of this report is present information to the Community Grants Committee (Committee) in order to seek Council support in the sponsorship of the Ashburton Anglers, 2026 Mack10K Fishing Competition.

The Committee is requested to recommend that Council support the Ashburton Anglers, 2026 Mack10K Fishing Competition with a sponsorship of \$20,000.

## **Background**

The Mack10K Fishing Competition, hosted annually by the Ashburton Anglers as an entirely volunteer community group, is a premier recreational fishing event held in Onslow each year. Established in 2019, the competition has quickly become a highlight on the Pilbara's sporting calendar.

Since 2019 the Mack10K Fishing Competition has grown significantly and fast become one of the premier fishing competitions in Western Australia, drawing anglers from across the state to compete in a single species challenge targeting Spanish Mackerel.

Since its inception in 2019, the Mack10K has seen substantial growth in participation and community engagement. The number of anglers has increased 335% from 92 in its first year to 400 in 2025. Prize categories have expanded from five to 17, enhancing the event's appeal. Local business sponsorships have grown by 35%, reflecting strong community support and investment.

The event's name, Mack10K, reflects its original major prize of \$10,000 awarded to the angler who lands the heaviest Spanish Mackerel. In 2025, to commemorate 100 Years of Onslow, the top prize has been doubled to \$20,000, thanks to the continued support of local business Munro's Contracting.

Beyond the competition, the Mack10K fosters community spirit, tourism, and marine education. The event regularly partners with Recfishwest and the Department of Primary Industries and Regional Development (DPIRD) to support the Fishing for Science program. In 2023, the competition saw a record 76 Spanish Mackerel samples donated for scientific research, contributing to valuable data on fish age, size, and reproductive health.

Held over a weekend in August each year, the Mack10K celebrations are based at the Onslow Sports Club and features a family friendly atmosphere, merchandise, and community engagement activities. The competition not only celebrates Onslow's rich fishing culture but also supports local businesses and promotes tourism for Onslow and sustainable fishing practices.

Council has supported Ashburton Anglers Mack10K in 2023, 2024 and 2025 with a Signature Event Grant of \$10,000, helping to ensure the continued success and growth of this iconic community-led event.

#### Comments

The Mack10 Fishing Competition has evolved into the largest blue water fishing event in Western Australia, with the 2025 competition selling out within eight hours of going live online. Its growing reputation continues to attract both participants and spectators from across the state, positioning Onslow as a premier destination for recreational fishing and regional tourism. The event contributes significantly to local economic activity, community pride, and visitor engagement.

Organised by the Ashburton Anglers, a dedicated volunteer-run community group, the Mack10K Fishing Competition has been successfully delivered since 2019. As the events scale and profile continue to grow, so too do the logistical and operational demands. The volunteer committee now faces increasing challenges in managing the event, including coordination, compliance, safety, and stakeholder engagement.

Importantly, the Mack10K has grown beyond just a fishing competition. It has become one of Onslow's premier annual events offering a family friendly atmosphere and a range of community engagement activities that appeal to residents and visitors alike whether or not they are participating in the competition. The event fosters a strong sense of community, celebrates Onslow's fishing heritage, and promotes sustainable practices through partnerships with organisations such as Recfishwest and DPIRD.

Ashburton Anglers have also secured a professional photographer and videographer for the 2025 competition. The images and footage will be used to promote the event and enhance Onslow's reputation as a top tourist destination, benefiting the Onslow community and the Shire's continued efforts in promoting Onslow.

A sponsorship of \$20,000 from the Shire of Ashburton would provide critical support to the Ashburton Anglers Fishing Club, enabling them to:

- Engage professional event management and security services to ensure smooth delivery and compliance.
- Enhance visitor experience through improved infrastructure and event coordination.
- Strengthen marketing and promotional efforts to increase sponsorship visibility and media coverage.
- Support volunteer capacity by alleviating pressure on the organising committee.

This sponsorship aligns with the Shire of Ashburton strategic objectives to:

- Promote regional tourism and economic development.
- Support community-led initiatives that foster pride and participation.
- Encourage sustainable event growth that benefits the broader Pilbara region.

A sponsorship of \$20,000 for the 2026 event will help to ensure the Mack10K remains a safe, successful, and sustainable celebration of Onslow's identity and community spirit.

## **Report Purpose**

The Community Grants Committee (the Committee) is required to consider the Signature Event and Activities applications in accordance with Council Policy – Community Donations, Grants and Funding.

The purpose of this report is to provide the Committee the applications received for review.

At the close of the application period, eight (8) applications were received for Signature Events and Activities (refer to Attachment 1).

The Committee is requested to receive these applications and the recommended outcome for each and support the recommendation presented for Councils consideration.

#### **Background**

The Shire supports the Signature Events and Activities funding under Council Policy – Community Donations, Grants and Funding as follows:

"Applications are available to incorporated and unincorporated associations for events and activities that provide a broad community benefit. Applications and amounts are assessed and determined by Council. Approved applications are set an allocation in the following years budget."

Previously, this funding was part of a three-year commitment from Council. That arrangement has now concluded, and applications will be submitted annually. This change aligns with the My Pilbara Home strategies, and all future applications will be reviewed each year to ensure strategic alignment.

Council Policy – Community Donations, Grants and Funding requires, as a minimum, the following criteria must be met to be successful:

- Applicant is to reside or operate within the Shire or be able to show a direct and substantial benefit to residents within the Shire.
- Assistance is not available retrospectively.
- Funds are to be used only for the purpose for which they are given or via agreed variations.
- Successful applicants are required to complete an acquittal report and submit this
  to the Shire within three months on the agreed completion date.

#### Comments

The Signature Events and Activities funding was promoted directly to clubs and organisations via email and on the Shire's public notice boards, website, and social media platforms.

At the close of applications on 12 August 2025, eight (8) applications were received.

- Tom Price Five (5) applications
- Onslow Two (2) applications
- Pannawonica One (1) application

Unfortunately, no applications were received from Paraburdoo, multiple emails and attempts to contact clubs and groups in town such as the Paraburdoo Red Dirt Rocks committee and Karingal were made with no response.

All applications have been assessed on the:

- criteria outlined in Council Policy Community Donations, Grants and Funding,
- general conditions, and
- criteria and compliance information provided.

The ongoing development of the My Pilbara Home Strategy encompasses several Council strategies, including events and programs. Recognising this as a valuable opportunity, we aim to align our events and grant processes with these strategies ensuring maximum benefit for the community.

As the current sponsorship agreements for the Tom Price Campdraft, Onslow Rodeo, Pannawonica Rodeo, and Paraburdoo Red Dirt Rocks are set to conclude this year, it is recommended that the budget allocation for these events be increased for the upcoming financial year. This adjustment will ensure adequate support for each event during the transition period. Moving forward, the intention is that the revised allocation will be sufficient to meet ongoing sponsorship needs, reducing the requirement for annual increases and supporting long-term planning and sustainability.

Grants are offered in two funding rounds each year, in July and February. There are two Tiers to this grant round as recently adopted by Council.

Tier 1 offers a value up to \$2,500 and Tier 2 offers a value of up to \$5,000. Applications are considered by the Community Grants Committee for subsequent recommendation to Council for determination.

Council Policy – Community Donations, Grants and Funding requires, as a minimum, the following criteria must be met to be successful:

- Applicant is to reside or operate within the Shire or be able to show a direct and substantial benefit to residents within the Shire.
- Assistance is not available retrospectively.
- Funds are to be used only for the purpose for which they are given or via agreed variations.
- Successful applicants are required to complete an acquittal report and submit this
  to the Shire within three months of the agreed completion date.
- Applicants who do not submit an acquittal will not be considered for future funding and they may be requested to return unused funds.

#### Comments

Round 1 of the Community Support Grants was promoted directly to clubs and organisations via email, and notices were placed on the Shire's public noticeboards, website and social media platforms.

As the Council policy and the Community grant guidelines were also recently introduced each previous applicant over the last two years was contacted and invited to attend a one-on-one teams discussion to go over any potential projects and applications.

At the close of the Round 1, 11 total applications were received, as follows:

- Onslow one (1) application,
- Pannawonica five (5) applications,
- Tom Price three (3) applications,
- Paraburdoo two (2) applications.

Furthermore, each applicant at the close of the round was contacted individually to discuss their application and followed up with an email requesting any supporting information. There are a number or groups that are still following up information, and if an application is approved, they have been advised that funds cannot be released without the supporting information.

All applications have been assessed on the:

- criteria outlined in Council Policy Community Donations, Grants and Funding,
- general conditions, and
- criteria and compliance information provided.

## **Report Purpose**

This report seeks the Community Grants Committees support to seek Council approval for the Pannawonica Dingoes Community Support grant application submitted in Round 1 of the FY2025/26 funding cycle.

The application requests retrospective funding for the purchase of a line marker, originally approved in Round 2 of FY 2024/25.

## **Background**

On 15 April 2025, Council endorsed a grant of \$2,500 to the Pannawonica Dingoes under the Community Support Grant Program (Round 2 FY 2024/25). The funding was allocated for the purchase of a line marker intended for shared use by the Pannawonica Football Team and the Pannawonica Cricket Club.

A letter of agreement was issued to the club on 29 April 2025, accompanied by a request to return the signed agreement and a completed new supplier form to facilitate payment. Due to the club representative's extensive involvement in coordinating multiple community events and programs, the required documentation was not returned until 21 July 2025.

In accordance with related Council policy and the Community Grant Guidelines, unclaimed funds within the approved financial year require a new application in the subsequent round. As such, the current submission is considered a request for retrospective funding.

#### Comments

While the guidelines clearly outline the requirement to reapply if funds are not claimed within the financial year, the club representative was unaware that this would apply in their case. The line marker was purchased with the understanding that reimbursement would follow, based on the original grant approval.

Given the circumstances, it is recommended that Council consider the application. The club acted in good faith and has demonstrated a commitment to enhancing community sports in the town. This situation also highlights an opportunity for the Shire to improve communication and support processes to ensure community members are fully informed of grant conditions and deadlines.

#### Consultation

Pannawonica Dingoes and Pannawonica Sports Club Committee was consulted with via phone and email, with a follow up site visit in July 2025.

#### **Report Purpose**

The purpose of this report is to seek Council support in the sponsorship of the 2026 Jarndunmunha (Nameless) Festival.

Council is requested to support the 2026 Jarndunmunha (Nameless) Festival with a total sponsorship package of \$150,000, with \$75,000 from the Inspire Community Partnership and \$75,000 from Shire funds.

## **Background**

The Nameless Festival, also known as the Nameless Jundunmunnah Festival, is a significant annual event held in Tom Price. The festival has been an iconic event, run by an entirely volunteer committee and has been an integral part of the isolated community of Tom Price.

Beginning in 1969 as a one-day show made up entirely of novelty events. It then progressed in the late 1970's to a weeklong event. The festival included a variety of events such as a Teen Dance, a ball, crowning of the Nameless Queen, quizzes, music, art exhibitions, fireworks, and novelty events.

In the 1980's, the festival expanded to include an open-air concert, wood chopping and axe throwing competitions, bottomless boat races, inter-town tug of war with Paraburdoo, mini-Olympics, and a ball.

The 1990's saw the Great Camel Race staged in front of a large crowd with four camels racing five circuits of the oval. In 2011, the festival added the aboriginal name Jundunmunnah which means 'place of rock wallabies' in the language of Eastern Guruma, the Traditional Landowners.

The festival continued to evolve and grow, attracting bigger numbers each year and was cancelled in 2020 due to Covid-19, with a welcome return in 2022.

#### Comments

With a newly formed committee re-establishing the event as a key feature of the Tom Price community calendar. The committee plan to deliver a full four-day program reflecting both a celebration of the town's heritage and a strategic investment in its cultural and economic future. The festival continues to hold strong relevance by fostering inclusivity, promoting regional tourism, supporting local businesses and artists, and encouraging youth engagement and volunteerism.

The proposed 2026 program retains iconic elements such as the King of the Mountain Race (in a new location), the Gardenia Ball, and the Festival Weekend, which includes a VIP Sponsors Evening, Twilight Markets, and a full-day festival program. These events are designed to engage both long-standing residents and new arrivals to town. The festival has already attracted interest from vendors and performers beyond the Pilbara region, signalling strong momentum and broad appeal.

The total projected budget for the festival is \$450,000, with confirmed and proposed contributions from key stakeholders including Rio Tinto and the Shire of Ashburton (\$75,000 each), and \$100,000 allocated from committee reserves. A \$200,000 grant application to Lotterywest is also planned, supported by professional grant consultants. The Nameless Committee has successfully held its Annual General Meeting, filled all executive positions, and commenced planning.

While a detailed delivery plan and budget overview have been provided (Attachment 1), further discussion is required to finalise sponsorship packages.

While the newly formed committee has demonstrated strong initiative and early planning for the 2026 festival, it is important to acknowledge that the event has faced challenges in recent years due to the inability to form a functioning committee. This history raises a level of risk in approving significant funding prior to the next AGM, as there is no guarantee of sustained leadership or operational continuity. While supportive of the current committee's efforts, any early release of funds should be carefully considered in light of this context, with appropriate safeguards or conditions to ensure accountability and delivery.
