18.1 PROPOSED NAMING OF ONSLOW RING ROAD AND RENAMING OF PORTION OF ONLSOW ROAD

Summary

The recent construction of the Onslow *Ring Road* by Main Roads Western Australia (MRWA) creates a new main entry into the Onslow townsite, delivering most traffic directly into the town's commercial centre via Simpson Street. The previous town entry is retained as a lower order road providing more direct access to Onslow's industrial and port facilities and airport.

Given that the main town entrance will be via the new road, it would normally be proposed that this be named 'Onslow Road', and the 2.7 km section of the existing Onslow Road extending north from the new intersection to its northern terminus at the intersection with Beadon Creek Road and Second Avenue be renamed.

This item is presented for Council to determine whether the Ring Road should be named 'Onslow Road', and if so, decide a new name for the old section of Onslow Road. Alternatively, in light of the local businesses expressing concerns about the need to change their addresses however, the option exists to not follow this normal protocol. Council could therefore determine that the overall best outcome for Onslow is to decide that the Onslow Ring Road be named to for example, 'Simpson Street'.

Background

When the Deposited Plan describing the new access road into Onslow, informally known as the 'Ring Road' (ATTACHMENT 18.1A) is submitted to Landgate, the Geographic Names Committee (GNC) requires that a name also be submitted for the road. While the Land Administration Act 1997 (LAA) makes provision for the subdivider to nominate a name, the surveyor (MNG) preparing the plan has requested that the Shire propose these names.

When dedicated and named, the Ring Road will be declared a main road, with Main Roads Western Australia (MRWA) being responsible for care, control, and maintenance. That section of Onslow Road between the intersection with Second Avenue and Beadon Creek Road, and the Ring Road (approximately 2.7km) is to be downgraded to a local road under the Shire's care and control. change relates to the agency responsible for maintenance and control and will not affect any physical characteristic.

Following informal discussion with staff at the Geographic Names Committee (GNC), who will assess and determine any proposed road name in Western Australia, it was considered that the most practical option would be to name the Ring Road as 'Onslow Road' up to the intersection with Back Beach Road where the road enters the physical townsite, at which point it would revert to the existing 'Simpson Street'. This would ensure that Onslow Road remains an unbroken, continuous road acting as the primary access and entry to the town.

Naming the Ring Road 'Onslow Road' then necessitates renaming a 2.7 km section of Onslow Road identified in **ATTACHMENT 18.1B**.

The Onslow Ward Councillor advises that the local businesses have expressed concerns about the need to change their addresses, so the option does exist to not follow the above protocol and Council could alternatively request that Onslow Road north of the new intersection retain this name and either propose a new name for the Ring Road, or request that it be named 'Simpson Street' as a continuation of this existing road. This would create an unusual situation where a right hand turn would be required from a main road to a local road in order to remain on the same named road. A risk is that this option may not be supported by GNC irrespective of whether Council believes that such a position is in the overall best interests of Onslow.

One other potential solution would be to rename that section of Onslow Road as a continuation of Second Avenue. This is considered an unviable solution due to the potential for this intersection to be redesigned to make the old section of Onslow Road intersect with these two other road in a 'T' configuration, thereby making the Beadon Creek port facilities more accessible to heavy traffic.

Should the old section of Onslow Road be renamed, the main impact would be to those properties with a street address to this road. Most of the land comprises Crown land (both managed reserves and unallocated Crown land), the Onslow Airport, three LandCorp development lots that will eventually be subdivided as part of future stages of the Barrarda Estate, and five freehold lots being:

- Lot 852 on DP 189280
- Lot 691 on DP 216606
- Lot 549 on DP 173181
- Lot 550 on DP 173181
- Lot 592 on DP 183750

Any proposed road name change would require consultation with these landowners and occupiers, and in anticipation of this agenda item, the Shire has undertaken informal, preliminary consultation to discover any strong opinions regarding this matter; these discussions are summarised under the 'Consultation' heading in this report.

Should an additional road name be required for the old section of Onslow road, Council could either select from the list of previously approved street names (ATTACHMENT 18.1C), or select a new name that meets the GNC selection criteria.

Each road naming option is discussed in greater detail below:

Ring Road to become 'Onslow Road'

While not specifically addressed in either the relevant Australian Standard (AS/NZS 4819:2011 Rural and Urban Addressing) or the GNC's Policies and Standards for Geographical Naming in Western Australia, the accepted standard practice in naming roads is to maintain the same name for an unbroken section of road. Section 5.6 of AS/NZS 4819:2011 provides the accepted exception to this naming convention that where a main road or highway passes through a town, the road should be renamed within the urban area, resuming its previous name on the other side of the townsite.

This exemption does not apply in this instance.

Other than in the case of passing through a townsite or other geographical feature, there is no other situation where a road name should change without some physical break in its continuity (e.g. major roundabout or road intersection).

This option is GNC's preferred option and creates a logical and legible road naming protocol that is intuitive to visitors in particular.

Retain 'Onslow Road' name for local road

The main advantage to retaining the name for the existing Onslow Road is that those existing freehold lots taking access from the road would not need to amend their location address and marketing materials. Given that Onslow has no mail delivery service, no change to mailing addresses would be required, and the town's relatively small size ensures there is little chance of visitors seeking affected businesses would become disoriented or fail to find newly-addressed lots. There would be however, a reasonable degree of business administrative disruption to changing marketing materials, telephone contact information, etc.

None of the Crown land (either UCL or managed reserve) would be significantly affected as these lots comprise non-commercial leases with limited visitors and no business identity. A number of these leases are also currently expired and under review by the Department of Lands.

As a potential affected landowner, LandCorp has been informally consulted and has advised that it has no objection to changing this road name.

Should Council request the GNC to name the Ring Road as 'Onslow Road' and rename the old section, affected landowners and occupiers will be formally consulted to determine whether renaming the bypassed section would create disproportionately adverse impact on those freehold lots. A strong reaction against the proposal may require reconsideration by Council to balance the relative merits of the alternative naming proposal.

Should Council resolve to request that Onslow Road retain its current name, the most logical name for the Ring Road would be 'Simpson Street' for the full extent of the new road (even though the suffix 'street' is only to be applied within a townsite) so it may be necessary to rename the existing Simpson Street as Simpson Road, with those lots on Simpson Street readdressed accordingly; this would affect 11 freehold lots.

Comment

The established protocol in this situation, and the most logical town planning outcome is to name the Ring Road as 'Onslow Road', and rename the older section with a name to be selected from Council's previously approved list of potential road names. This would avoid creating a situation where it is necessary to make a right hand turn to remain on the same road, a proposal that is unlikely to be supported by GNC.

Naming the Ring Road as 'Onslow Road' ensures that the main road leading to Onslow is named after the town and does not create a situation where the main entry to the town changes name at a visually arbitrary location.

Any short-term inconvenience experienced as a result of this proposed road name change will hopefully be offset by the logical implementation of an intuitive road naming protocol where Onslow Road leads directly to the Onslow townsite.

In addition, this proposed road name change offers an opportunity to recognise either a previous significant Onslow resident, or the region's indigenous heritage through the selection of a road name to one of the town's major thoroughfares.

In light however of the apparent concerns expressed by local businesses about their need to change their addresses and marketing materials, it would be appropriate to "give that option a try" (i.e. of

leaving the relevant section of Onslow Road unchanged) if Council is of the view that this option is in the best overall interests of Onslow.

Consultation

Those landowners who would be affected by any name change to Onslow Road have been contacted via telephone to determine if any affected owner or occupier strongly objected to the proposal being presented to Council. None of those persons contacted objected at the time to the proposal, although in some cases it was necessary to leave messages, not all of which were returned.
