Summary

The draft budget for the year ended 30 June 2011 was workshopped by Council on 4 August 2010 at the Mecure Hotel in Perth.

The statutory form of the budget has now been finalised, taking into account Council's input at the workshop. The document is now submitted to Council for formal adoption.

The draft statutory budget has been circulated under separate cover.

At the 18 August 2010 Ordinary Meeting of Council the 2010/11 Budget was not adopted by absolute majority and is now represented to Council for adoption.

Background

The draft budget for the year ending 30 June 2011 was workshopped by Council on 4 August 2010 at the Mecure Hotel in Perth (in conjunction with a Special Meeting of Council).

The statutory form of the budget has now been finalised, taking into account Council's input at the workshop. The budget document is now submitted to Council for formal adoption.

Minutes 26 August 2010

At the 18 August 2010 Ordinary Meeting of Council the 2010/11 Budget was not adopted by absolute majority and is now represented to Council for adoption.

Comment

The draft budget has now been finalised in the required, statutory form.

Included in the Budget Resulting from the Budget Workshop are:

- 1. Inclusion of Solar Light and Stainless Steel Table at Beadon Point.
- 2. Inclusion of repairs to the Tennis Courts in Paraburdoo (included in scope of Paraburdoo Town Centre Revitalisation Program)

Also in the course of completing this process the programming for the Tom Price Sporting Precinct Project was reviewed and the project was split over two financial years, \$ 4,716,300 in 2010/2011 and \$1,057,000 in 2011/2012. As discussed at the Workshop significant funding of approximately \$692,000 is still required for this project.

The final draft statutory Budget for the 2010/11 Financial Year has previously been distributed to Councillors

The financial implications of the budget are based upon the objective of achieving a balanced budget at 30 June 2011 after carrying out normal operational requirements and an extensive capital program.

The budget has been prepared on the basis of achieving a near normal year of operations and an ambitious capital program while also consolidating the management and operational aspect of the Shire.

The budget has been drafted with regard to the Strategic Plan and with regard to the Principal Activity Plan.

2. Due Date for Payment of Rates

In accordance with the provisions of section 6.45(1) of the *Local Government Act* 1995 offer to ratepayers the opportunity to pay rates and rubbish charges in instalments as follows:

One (1) instalment due on 11 October 2010

Two (2) instalments due on 11 October 2010

14 February 2011

Four (4) instalments due on 11 October 2010

13 December 2010

14 February 2011

14 April 2011

3. Administration Charge & Interest Rate on Instalments

In accordance with the provisions of section 6.45(3) and (4) of the *Local Government Act 1995* and 67 and 68 of the Local Government (Financial Management) regulations 1996, impose the following charges for ratepayers electing to pay by instalments:

Administration Fee: \$10.00 per instalment

Interest Charge: 5.5% (Calculated on simple interest basis from the date of the first instalment to the due date of each subsequent instalment)

4. Interest on Overdue Rates

In accordance with the provisions of section 6.51 of the *Local Government Act 1995* and 70 and 71 of the Local Government (Financial Management) regulations 1996, impose interest on outstanding rates and charges as follows:

On outstanding rates and charges

Where no instalment election has been made: 11% (imposed from the later of when it becomes due and payable or three months from the date of issue).

On outstanding instalments of rates and Service charges: 11% (imposed from when each instalment becomes due and payable).

5. Fees & Charges

In accordance with Section 6.16(3) of the Local Government Act 1995 adopted the Schedule of Fees and Charges as per the 2010/2011 Budget document.

6. Adoption of Material Variance Level for Reporting

In Accordance with Section 34(5) of the Local Government (Financial Management) Regulations 1996 adopt the following materiality thresholds:
