Dear Mr Donohoe

I refer to your correspondence dated 12 April 2023 and advise that, in accordance with the authority delegated by the Minister for Local Government, I have approved your application, under section 5.69(3) of the *Local Government Act 1995* (the Act).

It has been noted that the Shire requires a minimum approval of two members in order to achieve quorum. Accordingly, approval has been granted for Cr Lynch and Cr Mladenovic to fully participate in the discussion and decision making relating to the following agenda item at the Special Council Meeting, to be held on 18 April 2023:

8.1 - CONTRACT FOR CONSULTANCY SERVICES - COMMUNITY LIFESTYLE AND INFRASTRUCTURE PLAN FOR TOM PRICE AND PARABURDOO

Conditions of approval:

- The approval is only valid for the 18 April 2023 Special Council Meeting when agenda item 8.1 is considered;
- The abovementioned councillors must declare the nature and extent of their interests at the abovementioned meeting when the matter is considered, together with the approval provided;
- The Chief Executive Officer (CEO) is to provide a copy of the Department of Local Government, Sport and Cultural Industries (DLGSC) letter of approval to the abovementioned councillors;
- The CEO is to ensure that the declarations, including the approval given and any conditions imposed, are recorded in the minutes of the abovementioned meeting, when the item is considered;
- The CEO is to provide a copy of the confirmed minutes of the abovementioned meeting to the DLGSC, to allow the DLGSC to verify compliance with the conditions of this approval; and
- The approval granted is based solely on the interests disclosed by the abovementioned councillors, made in accordance with the application. Should other interests be identified, these interests will not be included in this approval and the financial interest provisions of the Act will apply.

In granting approvals of this kind, my primary objectives are to enable the council to have a sufficient quorum to resolve the matter, while also ensuring that the number of conflicted councillors voting on a matter is minimized

For this reason, it is not always possible for me to approve all of the councillors who might be seeking to participate on an agenda item when a large number of potential conflicts are involved.
